WORK SESSION

Mr. Chip England, County Engineer, discussed the 1.6 acre parcel on the River's Edge Lagoon site and potential uses for it. The Utilities Department has been maintaining this property. This parcel is not being used by the department and they are looking for direction from the Board for ideas for usage. Some options discussed were to sell the property, plant trees to reforest it to its natural state, recreational use, or possibly a community garden. The Board agreed to have staff to research to see if the property is buildable. Once the information is provided, they will discuss plans for the property further.

Mr. George Poulson, Director of General Services, discussed a walkway view from the Courthouse to the Post Office and a walkway view from the Administration Building to the Scott Park Pavilion. The Board agreed to have Buildings and Grounds move forward with both projects.

Chief Keith Early and Officer Alexis Grochmal discussed the current Taxi Cab Program in the County. The expenses outweigh the benefit to the Community. The Police Department and the Commissioner of Revenue is requesting to work together with the County Attorney to revise or repeal the Ordinance. Mr. Ashcraft stated that that Planning Commission will meet on December 15 at 7:30 p.m. in the Board Room. The Wreaths Across America Veteran's Ceremony will be on December 17 at 11 a.m. at the City Point Cemetery. There will be an Animal Services Center Pet Adoption on December 17 from 9 a.m. to 2 p.m. at the Boulevard Flowers in Colonial Heights. There will be a Jackie Bradley, Jr. Day on December 17 from 10 a.m. to 2 p.m. at Swader's Sports Park. The Prince George TRIAD Christmas Luncheon will be on December 19 at 12:00 Noon at the Parks & Recreation Community Center. The County Offices will be closed for Christmas Break December 23 – 26. The Prince George Ruritan Club is selling live Christmas trees at its location off Ruffin Road. 'No Shave November' by Prince George Public Safety personnel raised approximately \$2,000 for St. Jude's Cancer Research. The State Corporation Commission reduces Virginia American Water rate increase that will save Prince George utility customers \$200,000. Beazley Elementary School students decorate Christmas tree in Administration Building using ornaments from recycled materials. The Benjamin Harrison Bridge Repair Dates are as follows: Wednesday, 12/14/16 - Overnight - Bridge Closed; Detours in Place. Thursday, 12/15/16 – 9:00 AM to 4:00 PM – Single Lane Closure/Install Elevator. The Prince George County 2016 Christmas Ornament now available for purchase.

REPORTS

Virginia Department of Transportation – Ms. Crystal Smith of VDOT gave a brief update on the road maintenance in Prince George County. She stated that the I295 project is moving forward and on schedule with a completion date of May, 2017. All pavement schedules are now complete. The major work on Temple Avenue where they are replaced the pipe structure is almost finished. There are several traffic engineer requests still out. There are signs ordered

to install no littering and no outlet and Chudoba. There is a speed study underway on Route 10 from Jordan Point to Tar Bay Road. The maintenance crews are now complete with the tree trimming on Hall Farm Road and Moody Road. They are continuing to patch on various routes. They have completed shoulders on Route 460 and Route 156. There is a meeting scheduled to do some major erosion repairs on James River Drive around the 12800 block. In addition to that, the crews are prepping their equipment for snow removal. Ms. Smith thanked the Board for being so wonderful to work with.

Fire and EMS Museum. Mr. Brad Owens, Director of Fire and EMS, introduced Ms. Carol Bowman of the Prince George Regional Heritage Center to talk about the Fire and EMS Museum project. Ms. Bowman stated that the Committee has met and an architect has looked inside the old Food Bank building to see what needs to be done. She stated that what they need to do at this time is to bring a crew to do a gentle demolition to maintain the integrity of the building. This will need to be done before they can move forward with seeking grant money. She asked the Board to grant them \$5,000 to be able to go in and complete this demolition. This money would come out of the Tourism Fund. The estimate for the demolition job is \$6,900. The Heritage Center will pay the remaining \$1900. The Chairman stated that they can make a motion to suspend the rules and add it to the end of the agenda.

PUBLIC HEARINGS

P-1. Public Hearing: Ordinance to amend the Code of the County of Prince George, Virginia, 2005, as amended, by amending sections 82-233 and 82-541 to revise allowances for adjustments to customer water and sewer charges related to leaks. Mr. Chip England, County Engineer, stated that there are a handful of customers each month that experience water or sewer leaks on their property and get resulting higher than normal charges on their Utility bill. Even when there is a leak on a customer's property, Utilities still has incurred the cost of providing the water service to the property. Current rules established by Code sections 82-233 and 82-541 allow Utilities to give some relief in the form of credits when customers can prove they have taken prompt action to fix the on-site leaks. The calculation of these credits under the current rules is very different for water versus sewer charge and can be very confusing to customers. Utilities is requesting consideration to revise two sections to make the allowed credit calculations for water and sewer charges consistent with one another, making them more straightforward to explain to customers and to implement. Under the revised rules, when a customer proves they have taken action to repair an on-site leak, Utilities would be allowed to reduce both water and sewer charges once in a 12 month period to the average amount charged on the customer's three previous bills. Chairman Robertson opened the public hearing at 7:32 p.m. There was no one to speak and the public hearing was closed. Mr. Carmichael made a motion, seconded by Mr. Hunter, to approve the ordinance amendment as presented. Roll was called on the motion.

ORDINANCE TO AMEND THE CODE OF THE COUNTY OF PRINCE GEORGE, VIRGINIA, 2005, AS AMENDED, BY AMENDING SECTIONS 82-233 AND 82-541 TO REVISE ALLOWANCES FOR ADJUSTMENTS TO CUSTOMER WATER AND SEWER CHARGES RELATED TO LEAKS

BE IT ORDAINED by the Board of Supervisors of Prince George County:

(1) That the Code of the County of Prince George, Virginia, 2005, is amended by amending sections 82-233 AND 82-541 as follows:

Sec. 82-233. - All water chargeable; leaks.

(a) All water passing through and being recorded on a water meter shall be charged to the user of record, from the time service is started ~~the meter is set~~ until the time service is terminated. ~~it is removed on written notice of the user, whether the water is used or wasted, as a result of a leak.~~

- (b) ~~When a water leak is discovered, and the customer or a leak occurs in the building plumbing, and where the owner, agent, or tenant does not take action within five days to repair the leak, the director may cause to have the water service terminated until such time as written notification is given to the director that the leak has been repaired.~~
- (c) ~~When a water leak occurs that was not due to the acts or negligence of the customer in water pipes or metered services and the owner, tenant or customer can prove action was taken to repair the leak within five days of when the leak was discovered or should have been discovered, has promptly made all necessary repairs, the director shall reduce any charges to the average of the total charges for the three previous bills. in excess of the amount of the average bimonthly bill for the premises to be billed at \$2.00 per 1,000 gallons. Adjustment for a water an underground leak will not be allowed again during the next only be made on one bimonthly bill per 12-month period. The director may give the same rebate where an unexplained problem or internal plumbing leak causes metered water consumption to exceed double the average bimonthly bill and the director believes the water was not beneficially used. Adjustments for an unexplained problem or internal leak may only be made once every 24 months except in cases of extreme hardship. Average bimonthly bills are to be determined by averaging bimonthly water consumption for three previous equivalent billing periods.~~

Sec. 82-541. - All wastewater chargeable; leaks exception.

- (a) ~~All water passing through and being recorded on a water meter or wastewater directly measured by a wastewater meter shall be charged at the rate of 100 percent for wastewater service, such charges being made to the user of record; from the time service is started the meter is set until the time service is terminated, it is removed on written notice of the user, whether the water is used or wasted as a result of a leak.~~
- (b) ~~When a water leak or a wastewater leak is discovered, and the customer does not take action within five days to repair the leak, the director shall terminate water service until such time as written notification is given to the director that the leak has been repaired.~~
- (c) ~~When a water leak is discovered that was not due to the acts or negligence of the customer and the customer owner, agent, or tenant can prove prompt action was taken to repair the leak within five days of when the leak was discovered or should have been discovered to repair the leak, the director shall reduce any charges to the average of the total charges for the three previous bills. department may allow credit against the current wastewater bill. Such credit shall be allowed to reduce the current wastewater bill to an amount equal to not less than two times the highest consumption in the previous 12 months. If a credit is given a premises for a leak on the wastewater bill, the same premises will not be allowed a credit for another leak during Adjustment for a water leak will not be allowed again during the next 12-month period.~~
- (d) ~~When a wastewater leak is discovered that was not due to the acts or negligence of the customer and the customer can prove action was taken to repair the leak within five days of when the leak was discovered or should have been discovered, the director shall reduce any charges to the average of the total charges for the three previous bills. Adjustment for a leak will not be allowed again during the next 12-month period.~~
- (e) ~~No adjustment for a water leak or a wastewater leak shall be made for charges based on wastewater directly measured by a wastewater meter.~~

ORDER OF BUSINESS

A-1. Resolution; Authorize the Fire & EMS Department to Complete and Submit a Grant Application to Virginia Office of EMS for Remount for Ambulance Fleet Number 110. Mr. Brad Owens, Director of Fire and EMS, stated that the Board of Supervisors changed its process earlier this year and required all grant applications requiring a match to come before the Board of Supervisors. This is a rescue squad assistance fund grant that they have applied

for numerous times in the past and have been awarded. They applied for a new ambulance last year and were denied. They were told they may have a better chance for a remount. They are now requesting permission to move forward with the necessary data gathering and resources needed to apply for the grant to do a remount for one of their medic units that was recently moved down to the Carson station. The vehicle is a 2003 with approximately 160,000 miles on it which is too much for a first response vehicle. The funds would be coming from the Apparatus Replacement Fund, not the General Fund. Resolution; Authorize the Community Corrections Department to Complete and Submit a Grant Application to the Supreme Court of Virginia for Wages, Benefits, Travel Costs and Supplies for Adult Drug Treatment Court. Ms. Betsy Drewry, Finance Director, stated that Community Corrections was recently made aware of a funding opportunity to assist with costs associated with the Virginia Drug Court Treatment.
