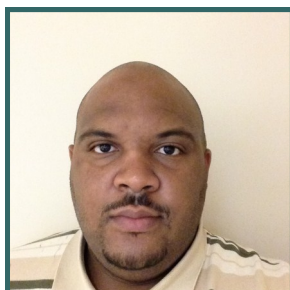

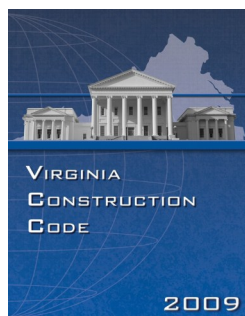
The Prince George County Department of Community Development and Code Compliance was recently awarded a grant from the Chesapeake Bay Restoration Advisory Committee providing funds to install markers on storm drains. Storm drains selected for marking will be in residential and commercial areas of the county that drain to either the Appomattox River or the James River.

The colorful markers say "NO DUMPING...DRAINS TO BAY". The markers are intended to inform and educate the public about the importance of, and vulnerability of storm drains. Storm drains carry water directly to nearby waterways. Stormwater can carry trash and pollutants straight into our streams and rivers....

Code Enforcement Update

With new online options for submitting complaints and an increase in public awareness of maintenance regulations, 2013 was a successful year for Code Enforcement in Prince George County.

2012 to 2013 Comparison

- Property Complaints increased 20%
- Property Violation Notices issued increased 98%
- Inoperable Vehicle cases increased 24%
